For warranty credit, the defective part must be returned to Blueridge at our main distribution warehouse. This warranty does not apply to labor, freight, or any other cost associated with the service, repair or operation of the unit. Blueridge will not pay for electricity or fuel costs, or increases in electricity or fuel costs, for any reason, including additional or unusual use of supplemental electric heat. This warranty does not cover lodging or labor charges. This warranty does not cover refrigerant. This warranty is in lieu of all other express warranties.
