



DEFINITIONS

The following definitions will apply to this Limited Warranty:

1. **"Blue Summit"**: refers to Blue Summit LLC, as well as its parents, affiliated companies, related companies, subsidiaries, divisions, departments, business units, representatives, predecessors in interest, successors, and assigns.
2. **"Residential Application"**: refers to any Blue Summit equipment installed in a Single or Multi Family Dwelling, Including Homes, Apartments, Condos used for personal, family or household use.
3. **"Non-Residential Application"**: refers to all premises that are not included in the definition of a Residential Application, including all applications that are not for personal, family, or household purposes.
4. **"Owner"**: refers to
 - a. the person or entity that originally purchased the Blue Summit equipment.
 - b. during the Warranty Period, the owner(s), and subsequent owner(s) of the premises where the Blue Summit equipment is originally installed.

I. LIMITED WARRANTY

Covered Equipment:

Subject to the terms below, this limited warranty (this "Limited Warranty") covers components within the following Blueridge-branded equipment (hereafter, the "Equipment"): **Split System Condensing Units, Split System Heat Pumps, Gas Furnaces, Oil Furnaces, Evaporator Coils, Air Handlers, Self-Contained Package Units.**

Care of Equipment:

Your new Equipment must be properly installed, operated, and maintained in accordance with the unit installation, operation and maintenance instructions provided with each Blue Summit unit. Failure to provide maintenance per Blue Summit instructions will void This Limited Warranty

Warranty Start Date: The warranty period begins on the "Installation Date" which refers to:

1. (When the Equipment is properly registered through www.blueridgewarranty.com) **The date of actual installation.**
2. (When the Equipment is not registered through www.blueridgewarranty.com or is ineligible for registration) **7 days after the date of shipment.**
3. (When the Equipment is unregistered, and a shipment date cannot be determined) **6 Months after the date of manufacture.**

Warranty Procedure: When service or warranty parts are required:

1. Make sure eligible equipment is registered at www.blueridgewarranty.com within 60 days of installation.
 - a. If the Equipment is not eligible for registration, you will default to the standard warranty. Continue to follow the steps below.
2. Be prepared to furnish the following information:
 - a. Complete model and serial number
 - b. Installing or certifying contractor information
 - c. Proof of required periodic maintenance, installation date and location.
 - d. An accurate description of the problem.
3. Call Blue Summit at (800) 865-5931 Choose extension 2 for technical support
 - a. If the Equipment is not registered, a licensed contractor must be present to process warranty claims

Excluded Components:

The following components are not covered by This Limited Warranty: cabinets, cabinet pieces, air filters, driers, refrigerant, refrigerant line sets, belts, wiring, fuses, oil nozzles, unit accessories and any parts not affecting unit operation.

Warranty Limitations:

1. All installations must be in compliance with applicable laws, regulations, codes, and ordinances.
2. **The Owner may be responsible for shipping charges.**
3. **The Owner is responsible for all costs associated with diagnostics and labor.**
4. The Equipment must be installed (or certified) by a qualified installer and the installation must adhere to the Quality Installation protocols of the Air Conditioning Contractors of America (ACCA), and these products must be registered with the manufacturer within 60 days of installation for the warranty to be in place.
5. All repairs of the Equipment containing the defective component must be made by a Licensed HVAC contractor using manufacturer-specified service components.
6. This Limited Warranty is void if the covered equipment is removed from the original installation site.
7. This Limited Warranty does not apply to, nor is any warranty offered by Blue Summit for any Equipment or components that have been stolen.
8. The installation of replacement parts under the terms of This Limited Warranty does not extend the original warranty period.
9. Blue Summit will not be responsible for 3rd party replacement part purchases.
 - a. Contact Blue Summit at (800) 865-5931 before purchasing any replacement parts from 3rd party vendors.
10. This Limited Warranty does not cover damage or defect resulting from:
 - a. Flood, wind, fire, lightning, mold, or installation and operation in a corrosive atmosphere, or otherwise in contact with corrosive materials (chlorine, fluorine, salt, recycled wastewater, urine, fertilizers, or other damaging substances or chemicals). Accident, or neglect or unreasonable use or operation of the equipment including operation of electrical equipment at voltages other than the range specified on the unit nameplate (includes damages caused by brownouts).
 - b. Modification, change or alteration of the equipment, except as directed in writing by Blue Summit.
 - i. This expressly includes the use of Leak Sealants when not directed by Blue Summit.
 - c. Operation with system components (indoor unit, outdoor unit, and refrigerant control devices) which are not an AHRI match or do not meet the specifications recommended by Blue Summit.
 - d. Operation of furnaces with return air temperatures of less than 60°F (16°C) or operation of a furnace field installed downstream from a cooling coil.
 - e. Use of contaminated or refrigerant not compatible with the unit.

II. RESIDENTIAL APPLICATIONS

The terms below Cover only Equipment installed in a Residential Application.

2a. Standard Limited Warranty Coverage

The Equipment is warranted by Blue Summit for the periods described below:

Parts Coverage: The covered equipment and covered parts are warranted by Blue Summit for a period of five (5) years from the installation date.

Compressor Coverage: The compressor for covered equipment is warranted by Blue Summit for a period of five (5) years from the installation date.

Heat Exchanger Coverage: All covered heat exchangers are warranted by Blue Summit for a period of twenty (20) years from the installation date.

If, during the coverage period specified above, a covered component fails because of a manufacturing defect, Blue Summit will provide a free replacement part to the Owner through a licensed service contractor utilizing a Blue Summit distributor. The Owner may be responsible for shipping charges and must pay all other costs of warranty service. Blue Summit will not pay labor involved in diagnostic calls or in removing, repairing, servicing, or replacing parts. Such cost may be covered by a separate warranty provided by the installer.

Note: In the event that a component covered by This Limited Warranty is no longer available, Blue Summit, at its option, through an established Blue Summit distributor, will provide a free suitable substitute component or will allow a credit toward the purchase of an equivalent new Blue Summit product (at the current suggested distributor's cost). If the date of original installation cannot be verified, the warranty period will be deemed to begin 7 days after shipment from Blue Summit to the Owner.

2b. Extended Limited Warranty with Online Registration

Blue Summit provides its air conditioning and heating products with a standard five-year parts warranty. This extended limited parts warranty (This "Extended Limited Warranty") is in addition to and is intended to supplement Blue Summit's standard 5-year parts warranty for Residential Applications. As such, this extended limited warranty provides for a total of 10 years of limited warranty coverage (Standard 5-Year Limited Parts Warranty Plus Additional 5-Year extended limited Parts warranty).

Blue Summit will extend the warranty provided the Owner registers the equipment online within 60 days of installation. Register your equipment at www.blueridgewarranty.com.

Once registered the warranty period is extended to the following:

Extended Parts Coverage: The covered equipment and covered parts are warranted by Blue Summit for a period of ten (10) years from the installation date.

Extended Compressor Coverage: The compressor for covered equipment is warranted by Blue Summit for a period of ten (10) years from the installation date.

Extended Heat Exchanger Coverage: All covered heat exchangers are warranted by Blue Summit for the **lifetime** of the equipment from the installation date.

Excluded Components: The following components are expressly not covered by this Extended Limited Warranty: cabinets, cabinet pieces, air filters, driers, refrigerant, refrigerant line sets, belts, wiring, fuses, oil nozzles, and unit accessories, and any parts not affecting unit operation.

Coverage Requirements -

1. The unit is a Blueridge branded unit.
2. The unit is installed in a residential application, **Non-Residential Applications are not eligible for extended coverage.**
3. The unit is properly registered at www.blueridgewarranty.com with Blue Summit within 60-days after the original date of installation or occupancy.
4. The Outdoor Unit and the Indoor Units must use R-410A refrigerant.
5. The unit is part of a complete, matched system and installed (or certified) by a state certified or licensed contractor in accordance with the unit installation, operation, and maintenance instructions provided with the unit.
6. Coils and air handlers are covered only when they are branded Blueridge and are purchased and installed as a system along with a qualifying Blueridge-Branded Split System AC or Split System Heat Pump unit. (Third party coils and air handlers are not covered).
 - a. Blueridge-Branded Split System AC or Split System Heat Pump units can only be registered with matching Blueridge-Branded coils and air handlers
7. Installation is in compliance with applicable laws, regulations, codes, and ordinances

Note: For residents of states where registration requirements are prohibited, such as California, registering The Equipment with Blue Summit is not a requirement for the Extended Limited Warranty. Residents of these states may either register as noted above or provide proof of when the unit was purchased and installed, such as an original invoice from the contractor with the Owner's name, address, purchase date, serial, and model number.

Extended Warranty Limitations

This Extended Limited Warranty is nontransferable. If the Equipment is transferred to a new Owner, the warranty will default to the standard warranty beginning 7 days after shipment and is no longer eligible for the extended limited warranty.

If this Extended Limited Warranty does not apply, then parts are warranted for the standard warranty period. If the standard warranty periods differ from the original warranty certificate, the periods stated on the original warranty certificate apply.

Any part replaced pursuant to this Extended Limited Warranty is warranted only for the unexpired portion of the Extended Limited Warranty term applying to the original part. The installation of replacement parts under the terms of this Extended Limited Warranty does not extend the warranty period.

This Extended Limited Warranty is an extension of Blue Summit's standard warranty. **Any implied warranty of merchantability or fitness for a particular purpose on this product is limited in duration to the term of this extended limited warranty.** Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you

III. NON-RESIDENTIAL APPLICATIONS

The terms below cover all Equipment installed in all Non-Residential Application

“Non-Residential Application”: refers to all premises that are not included in the definition of a Residential Application, including all applications that are not for personal, family, or household purposes.

3a. Standard Limited Warranty Coverage

The Equipment and covered parts are warranted by Blue Summit for the periods described below:

Parts Coverage: The covered equipment and covered parts are warranted by Blue Summit for a period of one (1) year from the installation date.

Compressor Coverage: The compressor for covered equipment is warranted by Blue Summit for a period of five (5) years from the installation date.

Heat Exchanger Coverage: All covered heat exchangers are warranted by Blue Summit for a period of ten (10) years from the installation date.

If, during the coverage period specified above, a covered component fails because of a manufacturing defect, Blue Summit will provide a free replacement part to the Owner through a licensed service contractor utilizing a Blue Summit distributor. The Owner may be responsible for shipping charges and must pay all other costs of warranty service. Blue Summit will not pay labor involved in diagnostic calls or in removing, repairing, servicing, or replacing parts. Such cost may be covered by a separate warranty provided by the installer.

Note: In the event that a component covered by This Limited Warranty is no longer available, Blue Summit, at its option, through an established Blue Summit distributor, will provide a free suitable substitute component or will allow a credit toward the purchase of an equivalent new Blue Summit product (at the current suggested distributor’s cost). If the date of original installation cannot be verified, the warranty period will be deemed to begin 7 days after shipment from Blue Summit to the Owner.

IV. TERMS AND CONDITIONS

The installation of replacement parts under the terms of This Limited Warranty does not extend the original warranty period.

Blue Summit shall in no event be liable for incidental or consequential damages, including but not limited to extra utility expenses or damages to property. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

Registering your product does not guarantee coverage under the Standard Limited Warranty or Extended Limited Warranty, or the application thereof. If the registered product does not meet all qualifying factors and/or requirements for the Standard Limited Warranty or the Extended Limited Warranty, or falls within one of the warranty limitations, the warranty will not apply to the equipment and/or your product regardless of the fact that the product is registered

Blue Summit makes no express warranties other than the warranty specified above. All implied warranties, including the implied warranties of merchantability and fitness for a particular purpose, are excluded to the extent to a period legally permissible. Should such exclusion or limitation of the warranty be unenforceable, such implied warranties are in any event limited to a period of one (1) year. Liability for incidental and consequential damages is excluded. Some states do not allow limitation of incidental damages, so the limitations or exclusions may not apply to you. Blue Summit will not pay electricity or fuel costs, or increases in electricity or fuel costs, for any reason whatsoever, including additional or unusual use of supplemental electric heat. This Limited Warranty does not cover lodging expenses or labor charges.

Blue Summit shall not be liable for any default or delay in performance under This Limited Warranty caused by any contingency beyond its control, including the unavailability of replacement parts. This Limited Warranty gives you specific legal rights, and you may also have other rights that vary from state to state.

The parties intend this writing as a final expression of their agreement with respect to warranties. Blue Summit makes no other warranty beyond that which is expressly contained in this writing.
